Complanant was advised that corporation was exempt from the KOMA as a not for profit corporation.</p>

Branson	<p>The District Attorney received a complaint against the Lawrence City Commission, the Douglas County Commission, the Board of Trustees of Lawrence Memorial Hospital, and the Board of Directors of the Lawrence-Douglas County Health Department regarding use of executive sessions and compliance with the statutory requirements for entering executive sessions. The complaint was referred to the Kansas Attorney General's Office because of a conflict of interest. The outcome will be included on the Attorney General's report for Fiscal Year 2015.</p> <p>The District Attorney received a complaint that the City of Lawrence violated the KORA by neglecting to respond to a request relating to the number of calls to the city police department during calendar year 2012 for each business licensed to sell alcoholic beverages, where the number of calls exceeded ten. It was determined that the city failed to respond to the KORA request within the statutory time frame, although the failure to comply with the statutory requirement was unintentional.</p>

Hunting	<p>A complaint was received that the Franklin County Agricultural Society, Inc., aka the Franklin County Fair Board, did not provide meeting minutes requested under the KORA. Upon investigation, it was determined that the KORA did not apply to the Society, a private, not-for-profit corporation.</p> <p>An individual complained that the two of the three members of the Pomona City Council were discussing city business after council meetings were adjourned in violation of the KOMA. The County Attorney determined that there was insufficient evidence to support the allegation.</p>
GEARY	Steven L. Opat	A former Milford City Councilor complained that the Council had taken binding action in an executive session. The County Attorney spoke with the City Attorney regarding the complaint, and based upon the County Attorney's investigation, he was unable to find that any binding action was taken; therefore, he did not find that there was a KOMA violation.

Moser	The County Attorney received a report that following the adjournment of a meeting of the Board of Supervisors of Unified Greeley County, a quorum of the Board may have had a discussion regarding how offices in the courthouse are staffed. The County Attorney sent the Board members a memorandum and email that made them aware of the complaint, that if such did occur it was a violation of the KOMA, and that such should not occur further. The County Attorney also provided the following information: informal discussions before, at breaks, or following meetings of the board have been determined to be subject to the KOMA (<i>Coggins v. Public Employee Relations</i>

		<i>Board</i> , 2 Kan. App. 416, 423 (1978)). Binding action or voting is not necessary; discussion itself triggers the KOMA (Kansas Attorney General Opinion 79-200). Two of the Board members involved admitted that such a discussion did occur and now understand that it cannot in the future.

This questionnaire was then used to create an agenda for the 6/13/2013 city council meeting. Following an investigation, the District Attorney found that no KOMA violation had occurred.</p> <p>A complaint was made that the City of Overland Park violated the KOMA by convening closed meetings by a majority of the members of an "Investment Committee." Upon investigation, the District Attorney found that this group was not an "agency" within the meaning of the KOMA because it had no authority beyond the authority of the City Manager.</p> <p>A complaint was made that the USD 231 School Board violated the KOMA when a series of emails was disseminated among several board members. A further violation was alleged regarding a subsequent request by the Board president for an executive session at the next meeting to discuss the subject of the emails with the Board's legal counsel. Following an</p>

		investigation, the District Attorney found that no KOMA violation had occurred.

KINGMAN	Matthew W. Ricke	The County Attorney received a complaint that three of five city council members met together to discuss the hiring of a new police chief and the person applying for the position was present. The Kingman County Sheriff's Office investigated and determined that the complainant was incorrect in her facts and that no KOMA violation took place.
KIOWA	J. Scott James	A complaint was made that the Mullinville City Council fired a city employee during an executive session and never ratified the decision in an open meeting. The Council and City Attorney were required to attend KOMA training. The matter was considered settled once proof of training was furnished to the Kiowa County Attorney's Office.
LABETTE	Hillary McKinney	A complaint was made that the Oswego City Council may have violated the KOMA by holding an "informational meeting" about an upcoming sales tax election without providing requested notice. Upon investigation, it was determined that there was never a majority of the Council present at the meeting; therefore it did not qualify as a meeting subject to the KOMA, and there was no KOMA violation.

The County Attorney's Office found that a violation had occurred. Because it was self-reported, no formal action was taken by the County Attorney. However, the County Attorney strongly recommended that the

		Board seek KOMA training. The County Attorney was subsequently advised that Board members received training at a subsequent meeting.

MARSHALL	Laura Johnson-McNish	A complaint was made that the USD No. 380 School Board held a special meeting without giving public notice and took action at the meeting to close a school-run day care facility. Upon investigation, the County Attorney learned that no one had requested notice of school board meetings. In addition, the matter was discussed in previous regular open Board meetings. The County Attorney did not find a KOMA violation.

Lewis	A complaint was received alleging that in connection with a proposal to change street names, the Plains City Council violated the KOMA by 1) having a work session after a regular meeting without keeping minutes; 2) preventing citizens from discussing the changes at public meetings; 3) ignoring a petition presented to the Council; and 4) making and publicizing a decision before voting in open meeting. The County Attorney investigated and determined that no actions of the council violated the KOMA. In particular: 1) The KOMA does not require minutes to be kept, except for executive sessions. Proper notice was given of the meeting. 2) The KOMA does not ensure a public right to speak, only to listen. 3) The KOMA does not address the issue of passing of petitions or the requirements for such. 4) There are no facts to support a KOMA violation.
MIAMI	Elizabeth Sweeney-Reeder	A complaint was received alleging that the Osawatomie City Council did not acquire property in the correct manner and requesting documents. No substantive KORA or KOMA violations were found.

The Board agreed to complete KOMA training. No further action taken.

Upon investigation, the County Attorney determined that the Council had violated the KOMA by taking binding action in a secret ballot. The County Attorney offered the Council a settlement agreement requiring it to void the action and taking KOMA training. The council agreed and complied with the terms of the settlement.</p> <p>A complaint was received that the USD 434 School Board may have violated the KOMA by improper use of executive sessions and taking binding action in executive session. Upon investigation, the County Attorney determined that the Board went into executive session for a valid reason (to discuss non-elected personnel) and did not take binding action during the session. No KOMA violation was found.</p>
OSBORNE	Paul S. Gregory	The County Attorney received a KORA complaint referred by the Kansas Attorney General's Office regarding a request for a copy of a city ordinance from the City of Downs, Kansas. The County Attorney asked the complainant to provide a copy of his written

		request for records, but no response was received.

The Board requested a vote of "confidential statements," and the complainants did not know the nature of the statements. No action was taken by the County Attorney's Office in this matter.</p> <p>The editor of the local paper filed a KORA complaint concerning Phillips County Economic Development when the assistant director would not provide him with minutes from the February 24th meeting. Per AG opinion 2013-5, minutes are not public until cited in an agenda that is prepared, finalized, and provided to board members. The newspaper was told it could pick up an agenda when they are ready for board members.</p>

The complainants were not able to provide any proof that a side meeting was held, or if such meeting was held, that it violated the KOMA. The County Attorney offered to investigate further if the complainant could provide specific details.

The complainant also said that a paid consultant who was making a presentation to the Committee said the public was not welcome at the presentation. The County Attorney investigated and found that the allegation was unfounded. Finally, the County Attorney confirmed that a Commissioner told the public not to attend any more Committee meetings, on the mistaken belief that the meetings were similar to staff meetings that were not open to the public. The County Attorney learned that immediately after the statement was made, the County Counselor advised that the meetings should be open, and the Commissioner advised the complainant prior to the next meeting that the meetings would be open. Therefore, no one was ever denied the opportunity to attend a Committee meeting.
