TOBACCO DIRECTORY UPDATE NOTIFICATION JULY 27, 2015

Below is a summary of directory updates published on July 27, 2015.

[Directory of Fire Standards Compliant Manufacturers](#)

- The manufacturer Farmers Tobacco Co. of Cynthiana, Inc. recertified thirty-four (34) brand varieties as FSC compliant, including nine (9) brand varieties of Baron American Blend brand cigarettes, sixteen (16) brand varieties of Kentucky's Best brand cigarettes, and nine (9) brand varieties of VB Made in the USA brand cigarettes.
- The manufacturer Global Tobacco LLC certified eight (16) total brand varieties of Global Classic brand cigarettes as FSC compliant, including eight (8) recertified brand varieties and eight (8) newly certified brand varieties.
- The manufacturer Lorillard Tobacco Company recertified forty-three (43) brand varieties as FSC compliant, including six (6) brand varieties of Kent brand cigarettes, nine (9) brand varieties of Maverick brand cigarettes, sixteen (16) brand varieties of Newport brand cigarettes, six (6) brand varieties of Old Gold brand cigarettes, and six (6) brand varieties of True brand cigarettes. In addition, one (1) brand variety of Maverick brand cigarettes and three (3) brand varieties of Old Gold brand cigarettes were removed and are no longer FSC compliant.
 - *Please note the brand Maverick is currently associated with ITG Brands LLC.*
 - *Please note the brands Kent, Newport, Old Gold, and True are currently associated with R.J. Reynolds Tobacco Company.*
- The manufacturer Philip Morris USA, Inc. recertified one-hundred sixty-nine (169) brand varieties as FSC compliant, including twenty-three (23) brand varieties of Basic brand cigarettes, twelve (12) brand varieties of Benson & Hedges brand cigarettes, five (5) brand varieties of Cambridge brand cigarettes, one (1) brand variety of Chesterfield brand cigarettes, one (1) brand variety of Commander brand cigarettes, one (1) brand variety of Dave's brand cigarettes, one (1) brand variety of English Ovals brand cigarettes, fourteen (14) brand varieties of L&M brand cigarettes, four (4) brand varieties of Lark brand cigarettes, sixty-one (61) brand varieties of Marlboro brand cigarettes, fifteen (15) brand varieties of Merit brand cigarettes, ten (10) brand varieties of Parliament brand cigarettes, three (3) brand varieties of Players brand cigarettes, two (2) brand varieties of Saratoga brand cigarettes, and sixteen (16) brand varieties of Virginia Slims brand cigarettes.
- The manufacturer Tobaccos USA Inc. recertified nine (9) brand varieties of Palermo brand cigarettes as FSC compliant.

Please be advised that all cigarettes sold or offered for sale in Kansas must comply with the Fire Safety Standard and Firefighter Protection Act, K.S.A. 31-601 *et seq.*, and the Requirements for Sale of Cigarettes Act, K.S.A. 50-6a01 *et seq.* Accordingly, the Directory of Fire Standards Compliant Manufacturers *must* be read in conjunction with the Directory of Compliant Non-Participating Manufacturers and the Directory of Compliant Participating Manufacturers in order to determine which cigarettes are legal for sale in Kansas.
