DIRECTORY OF COMPLIANT NON-PARTICIPATING MANUFACTURERS

OCTOBER 27, 2017

The Non-Participating Manufacturers and brand families listed herein are presently compliant with the Requirements for the Sale of Cigarettes Act, K.S.A. § 50-6a01, *et seq.*

To be legal for sale in Kansas, all cigarettes must comply with the Requirements for the Sale of Cigarettes Act, K.S.A. § 50-6a01, *et seq.*, and the Fire Safety Standard and Firefighter Protection Act, K.S.A. § 31-601, *et seq.*, and rules and regulations adopted thereto. Therefore, this directory must be read in conjunction with the Directory of Fire Standards Compliant Manufacturers.

Please be advised of the following:

- It is illegal to affix Kansas tax indicia to a package of cigarettes of a tobacco product manufacturer brand family not included on this directory or the Directory of Compliant Participating Manufacturers. K.S.A. § 2015 Supp. 50-6a04(a)(1).
- It is illegal sell, offer, possess for sale in Kansas or import into Kansas, cigarettes (including RYO) of a tobacco product manufacturer brand family not included on this directory or the Directory of Compliant Participating Manufacturers. K.S.A. 2015 Supp. § 50-6a04(a)(2).
- It is an unlawful and deceptive trade practice violation under the Consumer Protection Act (K.S.A. § 50-626) for a stamping agent to sell or attempt to sell to a retail dealer or consumer, and for a retail dealer to sell or attempt to sell to a consumer, cigarettes in violation of the Requirements for the Sale of Cigarettes Act, K.S.A. § 50-6a01, *et seq.* K.S.A. § 50-6a17(a).
- Violating these laws may result in the following:
 - A civil penalty of up to 500% of the retail value of the cigarettes (including RYO) involved or \$5,000. K.S.A. § 50-6a14(a).
 - The surrender of profits, gains, gross receipts or other benefits. K.S.A. § 50-6a17(c).
 - Criminal penalties depending on the number of previous convictions. For a first conviction, a Class A Misdemeanor with fines ranging from \$1,000 to \$2,500 and up to one year imprisonment; for a second conviction, a severity level 9 nonperson felony with fines ranging from \$10,000 to \$100,000 and sentencing under K.S.A. § 2014 Supp. 21-6804; for a third or higher conviction, a severity level 9 nonperson felony with fines ranging from \$50,000 to \$100,000 and sentencing under K.S.A. § 2014 Supp. 21-6804. K.S.A. 2015 Supp. § 50-6a16.
