- If you have been a licensed private detective as an employee of one private detective agency and wish to be a licensed private detective as an employee of another private detective agency:

**Verification of Employment:** You and you new private detective agency employer must *both* sign the Statement of Employment

- If you have been a licensed private detective as an employee of a private detective agency and wish to be licensed as an independent private detective:

**Bond/Insurance/Deposit:** You must provide verification of a corporate surety bond in the amount of \$100,000; a certificate of insurance showing general liability insurance which provides coverage in the amount of \$100,000 for bodily injury or property damage caused by negligence and errors or omissions; **or** verification of \$100,000 cash deposit with the State Treasurer.

- If you have been licensed as an independent private detective and wish to be a licensed private detective as an employee of a private detective agency:

**Verification of Employment:** You and you new private detective agency employer must *both* sign the Statement of Employment
