JOURNAL ENTRY OF CONSENT JUDGMENT

The parties to the above proceeding have stipulated that they are in agreement with the following statement of understanding and this consent judgment.

STATEMENT OF UNDERSTANDING

1. Jim Trione, d/b/a King, Inc., admits he is the defendant in this case and has been properly served with process. This court has jurisdiction over the parties and subject matter.
2. Plaintiff and defendant have each of them stipulated and consented to this judgment without a trial or other adjudication of any issue of fact or law herein.
3. The provisions of this consent judgment are applicable to the plaintiff and defendant, and their agents, employees, and

4. Defendant shall not, <sup>in violation of K.S.A. 50-624,</sup> solicit consumers, enter into contracts, request and accept prepayment on the contract while defendant fails and refuses either to complete the contract or refund the money. Such activity by Defendant shall constitute a deceptive act and practice and violation of the Kansas Consumer Protection Act.

5. Defendant shall pay to Kenneth E. Denton of Monument, Kansas the amount of \$140.

6. Defendant shall pay the costs of this action.  
 7. By his consent Defendant does not admit violation of applicable state law. IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Statement of Understanding set forth above shall be, and it is, the order of this court, and the court approves such Journal Entry of Consent Judgment in accordance with its precise terms, thereby constituting the consent judgment.
