Defendants Robert Lewis, American Cemeteries of Missouri, Inc.,

Mount Hope Cemetery Association, Quindaro Cemetery and the unknown defendants do not appear.

The court being fully and duly advised finds as follows:

- 1) Plaintiff filed its petition on May 10, 1994.
- 2) Defendant, American Cemeteries of Missouri, Inc., was served by certified mail upon its president, James Custer at 4207 N. 19th Ave., Phoenix, AZ.
- 3) Defendants Robert Lewis, Mount Hope Cemetery Association, Quindaro Cemetery and the unknown defendants were served by publication notice. Notice of Suit was published once a week for three consecutive weeks in the The Wyandotte Echo. Proof of such publication has been filed with this court pursuant to K.S.A. 60-312(c).
- 4) This action was brought by the Attorney General of Kansas pursuant to the Kansas Cemetery Corporations Act, K.S.A. 17-1366 and K.S.A. 17-1367.
- 5) The defendants, American Cemeteries of Missouri, Inc., and/or Robert Lewis, are the last known owners of record of Mount Hope Cemetery.
 - 6) The legal description of Mount Hope Cemetery is:

TRACT I

Commencing at 346.5 feet West of the Southwest corner of the Southwest quarter of Section 31, Township 10, Range 25, in Kansas City, Wyandotte County, Kansas; thence North 841.5 feet; thence West 627 feet; thence South 841.5 feet; thence East 627 feet to the

point of beginning, except any part thereof taken or used for public road purpose.

TRACT II

Commencing at a point 30 feet North and 30 West of the Southeast corner of the Southwest quarter of Section 31, Township 10, Range 25, in Kansas City, Wyandotte County, Kansas; thence West 316.5 feet; thence North 811.5 feet; more or less to the South line of of of the Kansas the right way Electric Railway; Leavenworth thence along the South line of said right of way to a point due North of the beginning; thence South to the point of beginning, except that part taken or used for public road purposes.

- 7) Defendants, American Cemeteries of Missouri, Inc. and Robert Lewis are cemetery corporations as defined by K.S.A. 17-1312(f).
- 8) Defendants, American Cemeteries of Missouri, Inc. and Robert Lewis have, for a period of at least one year, failed to care for graves, grave markers, driveways and buildings.
- 9) Defendants, American Cemeteries of Missouri, Inc. and Robert Lewis have not made annual reports to the Secretary of State pursuant to the provisions of K.S.A. 17-1312(a) et seq. and amendments thereto.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- Any and all cemetery corporations holding title or interest in Mount Hope Cemetery are hereby dissolved.
- 2) Mount Hope Cemetery is hereby declared to be abandoned pursuant to K.S.A. 17-1367.
- 3) Title to all property described in paragraph 6 above is hereby transferred to the Municipality of Kansas City, Kansas, pursuant to K.S.A. 17-1367.
- 4) All entities with records or funds of Mount Hope Cemetery shall transfer same to the Treasurer of City of Kansas City, Kansas, and such records and funds shall become the property thereof.

5) The Municipality of Kansas City, Kansas, shall be responsible for maintenance of said cemetery.
