## JOURNAL ENTRY OF JUDGMENT

This matter comes on for hearing on this \_\_\_\_\_\_ day of February, 2008, on the application of Bank of America, N.A. ("Petitioner") for an order and judgment terminating the trust in issue, and releasing and discharging Petitioner from any further responsibility herein. Petitioner appears by and through its attorneys, J. Eric Engstrom and William P. Tretbar of Fleeson, Gooing, Coulson & Kitch, L.L.C. The City of Wichita ("the City") appears by and through its attorneys, Elizabeth Harlenske and Jay C. Hinkel of the City Attorney's Office. The Kansas Attorney General's office ("the Attorney General") appears by and through Assistant Attorney General Joseph N. Molina. StoneMor Kansas, LLC ("StoneMor") appears by and through its attorney is attorney, Kathryn G. Lee of Husch & Eppenberger, LLC. The Board of Control of the Old Mission Mausoleum ("the Board of Control") appears by and through William Tinker, Jr. in his capacity as a member of the Board of Control and its designated agent for purposes of these proceedings. There are no other appearances.

WHEREUPON, the Court finds that pursuant to the Court's prior orders, Petitioner has turned over to the City of Wichita all remaining funds of the Old Mission Mausoleum trust fund to the City, that the City has acknowledged receipt of the funds and that the City's receipt has been filed herein;

WHEREUPON, the Court finds that the Petitioner as Trustee has fully complied with all provisions of the Court's prior orders and that, in line with said orders, this matter is ripe for the entry of an order terminating the trust in issue, and releasing and discharging Petitioner at trustee.

IT IS, THEREFORE, BY THE COURT ORDERED, ADJUDGED AND DECREED that the Old Mission Mausoleum trust fund should be and the same is hereby terminated. IT IS FURTHER ORDERED that Bank of America, N.A. and its corporate predecessors should be and are hereby fully released and discharged from any liability arising from its administration of the Old Mission Mausoleum, its trust, and the trust's termination. IT IS FURTHER ORDERED THAT the Board of Control of Old Mission Mausoleum and its trust, and its current members and their predecessors should be and are hereby fully released and discharged from any further liability herein. The parties will bear their own costs.
