ORDER ADOPTING MEDIATION AGREEMENT AS ORDER OF THE COURT

NOW on this 20th day of December, 2017, comes before the Court Plaintiff's Motion to Adopt Mediation Agreement As Order Of The Court, as previously scheduled. Plaintiff, State of Kansas, ex rel. Derek Schmidt, Attorney General, appears by and through counsel, Assistant Attorneys General Robert Reynolds and Kathryn Carter. Defendant appears Pro Se.

Being duly advised in the premises, finding that due notice has been provided as required by law, the Court makes the following findings of fact and conclusions of law:

1. The parties engaged in mediation.
2. Parties agreed to specific terms and executed an agreement so stating.
3. That agreement is binding on the parties.
4. The agreed mediation agreement was filed with the Court on November 27, 2017.
5. That agreement provides authority to the Court to enter judgment consistent with the terms.

IT IS THEREFORE ORDERED AND ADJUDGED AND DECREED that judgment shall be

entered as follows:

- a. Defendant is ordered to pay consumer restitution in the amount of \$9,477.25 to consumers as follows:

i. Judith Hollabaugh	\$188.00
ii. Manuel Vargas	\$1,000.00
iii. Michelle Bleek	\$200.00
iv. Una Thomas	\$189.25
v. Romana Voutas	\$303.00
vi. Elizabeth Leech	\$1,940.00
vii. Other Kansas Consumers	\$5,657.00

viii. Total	\$9,477.25

- b. Defendant is ordered to pay investigative fees in the amount of \$5,567.40.
- c. Defendant shall pay \$20,000.00 in civil penalties that shall be suspended so long as she is in compliance with this order.
- d. Defendant and Plaintiff agree that Defendant will refrain from engaging in any acts or practices that violate the Kansas Consumer Protection Act, K.S.A. 50-623 et seq.
