I ask that you give serious consideration to our budget request for added staff to handle this increased workload so we will be able to promptly process claims. Thanks to your efforts last session, funding is available for such increased staff if authorized.

#### INTRODUCTION

The Kansas Legislature, in 1978, established the Crime Victims Reparations Board (later named the Crime Victim's Compensation Board) pursuant to K.S.A. 74-7301, et seq. recognizing that innocent victims of crime have been overlooked by the criminal justice system. In 1989, pursuant to recommendations of the Attorney General's Victims Rights Task Force, this legislation was the subject of extensive revision, including placement of the Board under the jurisdiction of the Attorney General and In answer to the directive of the enhancement of funding sources. Legislature, the Crime Victims Compensation Board during its existence (July 1, 1978 - June 30, 1989) has made awards to 1,890 victims in Kansas for out-of-pocket medical expenses, loss of earnings or support, burial expenses and other costs associated with the treatment of their injuries, sustained as a result of being a victim of a violent crime. In its eleven years of operation the Crime Victims Compensation Board has awarded a total of \$3,865,118 for payment of these losses because it was the last resort for the injured, innocent victim.

#### I. GENERAL PROGRAM INFORMATION

The Crime Victims Compensation Board is appointed by the Attorney General and consists of three members: Charles M. Hart, Augusta, Chairperson; Dorthy Miller, Pittsburg, appointed to replace Georgia Nesselrode, Olathe, whose term expired 6-30-89; and Carlos Cooper, Kansas City.

There are four fulltime staff members: the Executive Director, an Investigator, a Secretary and a Keyboard Operator II.

The Crime Victims Compensation Board provides funds to victims of criminally injurious conduct, or their dependents in cases of death, in the payment of medical care, rehabilitation, rehabilitative occupational training and other treatment and care if it is determined by the Board, after thorough investigation that: (1) the victim did not provoke the incident on which the claim is based; (2) the incident occurred in Kansas; (3) the incident was reported to the proper law enforcement agency within 72 hours; (4) the application for compensation was filed within one year of the incident; (5) the victim was not an accomplice to the incident; (6) economic loss totals more than \$100 and has not been recouped from other sources including collateral sources.

Work loss and dependent economic loss are limited to \$200 per week; expenses in any way related to funeral, cremation or burial are limited to \$2,000 (\$750 prior to July 1, 1989). Compensation payable to a victim or dependent may not exceed \$25,000 (\$10,000 prior to July 1, 1989). It is incumbent on the Board to verify that all information contained in the application is true and that the amounts requested are the responsibility of the claimant and a direct result of the incident on which the claim is based.

The Crime Victims Compensation Board had experienced an increase in claims filed each year since FY 82 and FY 90 is expected to be the most dramatic based on 453 claims filed in the first six months of the fiscal year, (compared to 555 claims during the entirety of FY 89). The average award per claim has fluctuated somewhat; the ratio of awards paid to claims filed has remained fairly constant at nearly 60%. Attorneys fees, as specified by statute, are paid only for assistance provided to the victim

in preparation of a claim at the rate of \$45 per hour and are awarded in addition to the victim/claimant award.

It is important to note that the increase in claims filed has occurred in the absence of any systematic information dissemination to publicize the compensation program until FY 90 at which time the Attorney General undertook a series of six informational meetings held throughout the state. Due to increasing awareness among law enforcement agencies, rape crisis centers, victim/witness programs, domestic violence programs, and the public in general, a continuation in the dramatic increase of FY 90 is projected.

In 1982 the Legislature assigned administration of the Rape Prevention and Crisis Intervention Services portion of the Federal Preventive Health and Health Services Block Grant to the Crime Victims Compensation Board. The Crime Victims Compensation Board had available \$35,952 during FY 89. A total of \$34,952 was disbursed to local programs, statewide. The funds were used for continuation of sexual assault prevention programs for children and adults and to create or maintain rape crisis intervention hotlines. Thirteen programs received grants from this fund. (See Page 12)

In 1984 the Legislature established the Protection From Abuse Fund (K.S.A. 74-7325) for the purpose of creating funds for programs providing services to victims of domestic abuse. The funding was established in K.S.A. 23-108a to provide an \$8 fee assessment added to marriage license fees received in each county throughout the state. In 1989 this provision was amended, raising the marriage license fee and further raising the fee assessment to \$23. Monies deposited in the Protection from Abuse Fund are administered by the Crime Victims Compensation Board in the form of grants-in-aid.

In FY 89 a total of \$220,542 was available in the Protection From Abuse Fund and a total of \$170,208 was disbursed to domestic abuse programs statewide. The funds were used to assist funding the administration and operation of the following services within domestic abuse programs:

- (a) 24-hour crisis intervention;
- (b) shelter or safehouse facilities;
- (c) assistance and referral for victims; and
- (d) emergency transportation.

Sixteen programs received grants from this fund in FY 89. (See Page 11)

In June 1986 the Crime Victims Compensation Board applied for and received a grant from the U.S. Department of Health & Human Services under the Family Protection from Abuse Fund. \$61,692 was awarded during FY 89 as supplemental awards to fifteen domestic violence programs.

#### **II. FUNDING OF REPARATIONS PROGRAM**

Prior to FY 83 the Crime Victims Compensation Board was solely funded by the State General Fund. During the 1982 Legislative session legislation was passed allowing the Crime Victims Compensation Board to receive an assessment of \$1 from each criminal court docket fee collected. The money received was to be deposited in the Crime Victims Compensation Fund and used solely for payment of reparations to victims. In order to meet the growing number of claims the 1985 Legislature increased to \$2 the court docket fee assessment earmarked for reparations. At the \$2 level receipts total approximately \$488,000 annually.

In FY 1986 the Crime Victims Compensation Board applied for and received, under the Victims of Crime Act of 1984, federal funds totaling \$116,000 to be used solely for payment of reparations (\$75,468 was expended in FY 86 and \$40,522 was carried forward into FY 87.) The FY 87 federal funds were not received until July 1987, hence the amount of \$131,000 was expended for payment of compensation during FY 88, together with the FY 88 federal funds received in June of 1988 in the amount of \$134,000. Consequently, federal funds in the total amount of \$265,000 were paid out in compensation during FY 88.

In FY 89 the Crime Victims Compensation Board was advised that it had been granted an award of \$189,000. The monies were not available until the end of June 1989, therefore only \$118,000 was requested during FY 89, leaving a balance of \$71,000 carried over to FY 90.

The FY 89 Legislature, recognizing the inadequacy of the Crime Victims Compensation funding approved a supplemental appropriation from the General Fund in the amount of \$109,973 for payment of claims. (This amount was provided to offset operating expenditures paid from the reparations fund).

The Legislature further in H.B. 2200 altered the funding source for compensation by deleting the deposit of \$2 of the criminal court docket fee to the Crime Victims Compensation Fund; and in its stead required the deposit of 19% of all fines, penalties and forfeitures received by each clerk of the district court of each county in the state into the Crime Victims Compensation Fund. The change of funding source increases the Crime Victims Compensation Fund by at least three times its previous receipts and insures that victims of violent crime will be more expeditiously reimbursed for their losses rather than waiting until funds are available.

#### **III. THE APPLICATION PROCESS FOR REPARATIONS**

The office receives numerous inquiries about eligibility for compensation. However, some inquiries are not processed by opening a file, because it can be determined that the victim was not eligible under the statute. Many of the ineligible inquiries concern automobile and property crimes which are excluded by the statute.

If the claim meets the eligibility requirements it is necessary to:

- obtain a description of the incident from law enforcement reports to determine if any provocation by the victim is indicated and, if so, to contact any witnesses to the incident for their statements;
- request any additional documentation which the claimant did not attach;
- 3) check with the respective District or County Attorney's office to determine if proceedings against the offender are imminent and, if so, to ask that restitution be considered at the time of sentencing;
- 4) verify the victim's relationship, if any, to the alleged offender;
- 5) consider other collateral sources reported as received by the claimant as a result of the incident; for example, Social Security, Worker's Compensation, private insurance, etc.
- 6) verify employment of the victim and/or the claimant in cases of wage loss or dependent economic loss;
- 7) verify the outstanding balances of hospital and doctor bills and their relevance to the claim; and
- 8) conduct a personal interview with the claimant regarding the information contained in the claim, and the involvement of the claimant in the circumstances surrounding the incident.

The Board is subrogated to the cause of the action of the applicant against the person responsible for the injury or death of the victim and also against the offender for the amount of damages sustained by the applicant.

#### IV. STATUTORY HISTORY

The Crime Victims Reparations Board (K.S.A. 74-7301 - 7318) was established by the Legislature in 1978 to alleviate the financial hardships caused by crime-related medical expenses and loss of income sustained by victims of violent crimes in Kansas. The statute also provides that some payment can be made to dependents of deceased victims.

The 1982 Legislature, H.B. 3004, amended K.S.A. 74-7305(2)(g) which allowed rape victims to be awarded compensation even though their economic loss would be less than \$100.

K.S.A. 1984 Supp. 74-7325 established the Protection From Abuse Fund for the purpose of creating funds for programs providing services to victims of domestic abuse. The funding source established in this legislation was an \$8 fee assessment added to marriage license fees received in each county throughout the state. Monies deposited in the Protection from Abuse Fund are administered by the Crime Victims Compensation Board in the form of grants-in-aid.

K.S.A. 1984 Supp. 20-362 was revised by the 1985 Legislature with S.B. 108 which increased to \$2 a fee assessment collected from the costs of each docket fee of a criminal proceeding in any county. This money was deposited in the Crime Victims Reparations Fund established by the original docket fee assessment legislation by the 1982 Legislature, H. B. 3005.

K.S.A. 74-7302 was amended by the 1985 Legislature, S.B. 344 to read as follows: "Within the limits of appropriations therefor, the board shall award compensation for economic loss arising from criminally injurious conduct if satisfied by a preponderance of the evidence that the requirements for reparations have been met." The legislative intent of this amendment was to further clarify that the Crime Victims Compensation Board is not an entitlement program.

S.B. 685 passed by the 1986 Legislature amended K.S.A. 74-7317 to allow moneys in the Crime Victims Reparations Fund to be used for state operations of the Board eliminating the commitment of the State General Fund. S.B. 685 also amended 74-7312 to allow moneys recovered by the Crime Victims Reparations Board through subrogation to be deposited into the Crime Victims Reparations Fund rather than the State General Fund.

S.B. 700 passed by the 1986 Legislature amended K.S.A. 74-7301(e) allowing victims of motor vehicle incidents involving DUI to be eligible to receive compensation for uninsured losses under the same restrictions and limitations imposed on victims of violent crimes. S.B. 700 also added New Section 2 to K.S.A. 74-7301 which requires that any profits from the sale of books, magazines, or other publications or from any movie, radio, television presentation or live entertainment regarding criminally accused or convicted person's (or their assignee's) thoughts, feelings, opinions, or emotions regarding the crime shall be paid to the Crime Victims Compensation Board. Any moneys received are to be deposited into an escrow account until distribution of funds can be determined as outlined in New Section 3.

K.S.A. 74-3701 was amended by the 1986 Legislature, S.B. 568 which provides specific language allowing the Crime Victims Compensation Board to apply for, receive and accept money from any source, including financial contributions from inmate worker wages thus allowing the State of Kansas to meet a mandatory certification requirement to participate in the Private Sector/Prison Industry Enhancement (PIE) Program administered by the Bureau of Justice Assistance of the U.S. Department of Justice.

The 1989 Legislature in H.B. (2200 substantially amended the Crime Victims Compensation statute as follows: (a) The name of the Board was changed to Crime Victims Compensation Board; (b) the Board was transferred to the Office of the Attorney General; (c) maximum allowed for funeral expense was raised to \$2,000; (d) the maximum amount allowable per claim was raised to \$25,000; (e) the financial means test was deleted; (f) eligibility for compensation was amended to include Kansas residents victimized in states without an eligible compensation program; (g) funding of the Crime Victims Compensation program was changed from reliance on the criminal docket fee to 19% of all fines, penalties and forfeitures collected by the clerk of the district court in each county. These changes were all effective July 1, 1989.

#### SUMMARY OF ILLUSTRATIVE CASES

#### 10264-88 and 10265-88

These 15 and 16 year old sisters were the victims of incest by their father. These acts occurred while the daughters were visiting under court order under terms of a divorce proceeding. The father was convicted at jury trial of aggravated incest. The girls are receiving counseling at a reduced rate and the Board has awarded \$295.00 in out-of-pocket counseling expense.

#### 10269-88

This 29 year old man was at a wedding reception where everybody was drinking when a fight broke out. The applicant admitted that he joined in the scuffle and was subsequently injured. The Board denied this claim for reason of "contributory misconduct."

#### 10330-88

This woman applied on behalf of her 17 year old daughter who was the victim of incest. The daughter was receiving mental health counseling. It was learned that the offender was placed in a diversion program, one condition of which was that he pay the counseling expenses of the victim. Upon verifying that he was indeed making such payments, the Board denied this claim for reason of "collateral sources."

#### 10414-88

This 48 year old man was operating a road grader in a friend's yard when two youths who had been drinking beer in a yard across the street approached him and began making racial slurs. The victim ignored the remarks and kept working, despite having a beer bottle thrown at him. Finally one of the suspects picked up a rock and struck the victim on the left side of his face. The victim suffered damaged sinus cavities, broken teeth and extensive facial cuts. The victim had some insurance coverage; however the Board approved \$455.00 in out-of-pocket medical expenses. The juveniles were apprehended and adjudicated offenders.

#### 10479-88

This 10 year old boy was the victim of a beating, however, total out-of-pocket expenses were less than \$100.00. The claim was denied due to the fact that allowable expenses were less than the \$100.00 CVCB minimum.

#### 10519-88

This 41 year old truck driver was in a truck stop bathroom when someone hit him in the back of the head and then stabbed him seven times. Robbery was apparently the motive. The suspect has never been identified. The victim had some insurance coverage and the Board approved \$2,844.11 in out-of-pocket medical expenses and wage loss.

#### 10522-88

This 3 month old baby was killed in a car wreck caused by a drunk driver, who was convicted of aggravated vehicular homicide. The Crime Victims Compensation Board approved funeral and burial expenses, wage loss for the father, and counseling expenses totaling \$3,474.32.

#### 10524-88

This 35 year old man was standing in the parking lot of a bar when an individual who had been involved in an atlercation in the bar jumped into his car and drove recklessly out of the lot, striking at least three bystanders. This victim was dragged under the car for 20 feet as the suspect vehicle fled. The driver was arrested and convicted of DUI. There was no insurance coverage. The Crime Victims Compensation Board's maximum award of \$10,000.00 was aproved to partially cover medical bills and wage loss.

#### 10531-88

This 27 year old woman was beaten and stabbed by her boyfriend. He was arrested and charged with aggravated battery. The victim, however, failed to cooperate with prosecution, so her claim was denied.

#### 11011-89

This 76 year old man was hit over the head with a brick and robbed in his own backyard by a man who came over on the pretense of wanting to buy a bicycle the older gentleman had for sale. Although the offender fled on foot, he was subsequently identified and convicted of robbery. The Board approved \$100.00 of out-of-pocket medical expenses after Medicare.

#### 11024-89

This 32 year old woman was killed and her body cremated at a mortuary where the killer was employed. He was subsequently convicted of first degree murder. The Board approved payment of \$404.44 for a headstone.

#### 11045-89

This 25 year old man was driving down a Kansas City street when he was hit head on by a car that ran a stop sign. He suffered severe head injuries. The offender crashed his car and fled on foot. The offender's car was determined to have been stolen and he was never located or identified. Because there was no evidence of a DUI being the cause of the wreck, the Board denied the claim.

#### 11176-89

This 41 year old cab driver was the victim of a stabbing while on the job. The perpetrator was apprehended and convicted. There was no insurance coverage and the Board approved its maximum award of \$10,000.00 to partially cover the medical bills.

#### 11212-89

This 30 year old woman was critically injured as a result of stab wounds inflicted by her ex-boyfriend. He had recently been released from prison and, being terrified of him, the victim had not been staying at her home. He found her, however, and attempted to kill her. The defendant was convicted and committed to Larned State Hospital. The Crime Victims Compensation Board has awarded \$6,053.27 in medical bills, wage loss and counseling expense.

#### 11223-89

This 40 year old woman was on her daily mid-morning run when she was accosted by the driver of a passing pickup. The driver stopped, grabbed the victim and dragged her by her neck over a barbed wire fence down to a creekbed, announcing his intention to rape her. She managed to fight him off, escape and flee for help. The suspect was arrested and convicted. The Crime Victims Compensation Board approved \$2,803.61 in medical and counseling expenses and wage loss.

#### 11260-89

This 16 year old girl was abducted from a shopping center by an individual posing as a security guard, taken to another location, raped at gunpoint and released the next morning. The perpetrator was arrested and convicted. The Crime Victims Compensation Board has approved \$2,189.70 in counseling expenses and wage loss.

#### 11275-89

This 15 year old boy was fatally wounded by a gunshot blast to the head. Investigation of the incident, however, concluded that this was an accidental shooting rather than an intentional act. The Board, therefore, denied the claim.
