		review of council meeting minutes, the County Attorney issued a 27-page report
		determining that the Council committed technical violations of KOMA despite good
		faith efforts to comply. Council members were warned by the County Attorney to
		heed the requirements of KOMA; strongly advised to obtain KOMA training;
		cautioned on operating committees without allowing the public the opportunity to
		attend meetings; and advised regarding the proper use of executive sessions. All
		city council members provided proof they received KOMA training.

Hill	Complaint received that the five member Brown County Dispatch Advisory Board violated KOMA by having two members discuss matters outside of Board meetings and that the two members were trying to reach a consensus with a third member. An investigation revealed that two members were regularly meeting outside the board meeting. There was no evidence that they contacted a third member for consensus. The County Attorney sent each Board member a copy of the KOMA/KORA outline from the Kansas Attorney General's Office and had each verify via email that they read the outline in full and agreed to comply with it. Each also indicated their awareness that it would be a violation of the Act for one member of the Board to communicate individually with other members of the Board about a common topic and try to reach consensus on an issue that requires binding action if collectively they make up a majority of the Board. No further complaints have been received since receipt of confirmation from the members.

Complainant was dissatisfied with the outcome of a city planning commission decision and questioned the role of commissioner versus private citizen. Complainant was encouraged to talk to private counsel due to the civil nature of the complaint. A second complaint was received regarding the same matter, with an added concern about planning and zoning requirements. Complainant was referred to private counsel, as well as Art. 27 of GC Zoning Regulations and Art. 7, Chapter 12 of the Kansas Statutes. Complainant was further advised his request was outside of the purview of the County Attorney's office, as the request was for a written legal opinion as to the validity of the commission's determination. A complaint was made that the fees charged by Garden City Community College to
		retrieve and copy requested records was excessive. Upon investigation, it was determined that the fees were reasonable in comparison with similar fees charged by other agencies in the county.

Belveal	A newspaper complained that the City of Oskaloosa improperly failed to disclose time cards in response to a KORA request by the media, citing an exemption for personnel records. Upon investigation, it was determined that the time cards were not covered by the exemption because they did not contain personal information other than names and were not stored with personnel records. The City was advised to provide the records. In a follow up request, the requester asked for the records in a different report format in an attempt to accomodate the City's concerns; however, the City indicated that no such record existed. An investigation confirmed that the record did not exist, and thus no violation was found.

JOHNSON	NSON Stephen M. Howe	A KOMA complaint was made regarding the Shawnee City Council. The complaint alleged that a majority of the council members met outside an open meeting to discuss city business. District Attorney determined serial communications did occur involving a city council vacancy, however, there was insufficient evidence that a majority of the council was involved in these communications. Therefore, no violation of KOMA was found.
		A letter was received suggesting that City of Mission Woods officials may have violated KOMA during a series of meetings with representatives of Pembrooke Hill School. A representative of the District Attorney's office spoke by telephone with the complainants regarding provisions of KOMA. It was determined that the complainants had not requested to be notified of special meetings of the city council. No KOMA violation occurred.
		A television reporter complained that the Prairie Village City Council illegally met in closed session to discuss taking action against an elected official. Following an investigation, correspondence was sent by the District Attorney stating that government bodies may exercise quasi-judicial functions under KSA 75-4318(g)(1), and that this is an exception to KOMA. No KOMA violation occurred.
		An individual complained that records related to the county and the consulting firm Franklin and Associates, aka Eastern Research Group, regarding the county's Solid Waste Management Plan were withheld. The District Attorney determined that all records that could be released were provided. There was no KORA violation.

		A KORA complaint was made stating that the Gardner School Board would not provide a copy of Section 2000 of the school district policy to a member of the audience during a board meeting. The District Attorney requested the complainant provide more details, and that the person denied access to records contact the District Attorney's Office. No additional information was ever provided to the District Attorney. The documents requested are readily available on the Gardner School District website. No KORA violation was found at this time. A complaint was made that the City of Shawnee violated KOMA when the city manager sent a questionnaire to each council member to create an agenda for the 6/13/2013 city council meeting. Following investigation, the District Attorney

The City passed an ordinance setting rules for orderly use of recording equipment during meetings that seemed to resolve any future issues. A KORA complaint was made by newspaper editor that the City of Greensburg tried to charge him for copies of records produced in response to his requests. Upon investigation, it was noted that the editor was making large requests involving hundreds of pages and considerable staff time. The editor refused to mediate his complaints. The City had a written policy concerning costs of copies; accordingly, this complaint was deemed without merit.

		A complaint was made alleging USD 259 violated KORA by not supplying student assessment preliminary results. The complaint was withdrawn upon receipt of the requested materials from USD 259. No further action was taken.
		A KORA complaint was made regarding the lack of response by the Sedgwick County Regional Forensic Science Center to repeated requests for copies of records. The Center had earlier supplied the requested records except one item not in its possession. The Center responded to the requests and directed the complainant to the appropriate custodian for the record it did not have. As the Center responded, no formal action was taken.
		An allegation was made that the Goddard City Council violated KOMA by taking binding action during executive sessions and did not properly stat the subject to be discussed and the justification for the executive session. Upon investigation, it was determined the Council did not take binding action in executive sessions. However, the Council did commit a technical violation of KOMA by only announcing the subject to be discussed, but not the justification for the executive session, which is required. The City agreed to participate in KOMA training and did so. No further action was taken.

		future violations might result in formal action.
		A KORA complaint was made that the Kansas City, Kansas Housing Authority improperly denied access to records and charged excessive fees with two records requests. Upon investigation, it was determined that the Housing Authority, before fulfilling the current, tried to collect payment for an earlier KORA request in which one of the requesters did not pay for or obtain the records. In addition, the rate charged for responding to later requests was higher than the rate charged for an earlier request for similar records because the Housing Authority learned in responding to the first request that researching for the records was actually more expensive than had been anticipated. The Housing Authority agreed not to seek payment for the records that were requested but not paid for or sent to the requesters, and agreed to provide records in response to the current request once the requested fee was paid. Investigation also established that the Housing Authority's refusal to provide a portion of the requested records because they obtained personal employee information was proper. No KORA violation was found.
