The Children's Advocacy Center Fund is maintained through two sources of revenue: (1) assessment fees in the amount of \$400 (in fiscal year 2014) levied on any defendant convicted of a crime under chapters 34, 35 or 36 of article 21 of the Kansas Statutes Annotated, and amendments thereto, in which a minor is a victim (K.S.A. 20-370); and (2) 0.11% of fines, penalties and forfeitures" collected by district courts (K.S.A. 74-7336).
