National Perspectives Testimony

Substance Abuse and Mental Health Services Administration (SAMHSA)

Kim Freese, Region VII Regional Administrator, her clinical work mainly focused on addiction services, in both community-based settings for women and children and in prison-based therapeutic communities. She then moved into executive leadership roles. Ms. Freese provided information on substance use disorder and considerations for Opioid Settlement funding. (Attachment 6)

Shatterproof

Kristen Pendergrass, Vice President, State Policy, stated that the three main priorities are educating and empowering communities, Shatterproof has ambassadors all over the country over 3000 of them in all 50 states. Second priority is addressing addiction stigma and they run state based anti-stigma campaigns. Third priority is helping people find quality addiction treatment, there is a lot of differences in terms of the quality of those treatment providers and the services they offer. One of the roles Shatterproof plays is convene a working group or a coalition of organizations that are proving technical assistance creating resources advising State and local governments on opioid settlement funds for non-profits.
