The house was in the area where several residential burglaries had recently occurred. He asked the man who he was and what he was doing and the man, a black male, said he lived there and was putting more trash in the can. He was asked to provide some identification but said he didn't have it with him, but he lived with his mother at that address. Officer asked if the car parked in the street in front of the house was his, and he replied it was his mothers. The officer ran the tag, found it	6/6/17	Complaint of racial profiling and harassment was unfounded. Due to criminal activity, the time of day, and the officer not knowing the person, it is a situation where he would be expected to make the contact and determine what activity was taking place at that time of night. The officer, however, was verbally counseled for failing to log the contact on his daily activity report. The officer was fairly new to the department, and his supervisor will monitor his activity closely to ensure he documents all contacts in the future and continues to do his patrol work properly.

		<p>responded to the name given by the man as his mother, and the officer cleared the scene. Mother came into the station later that day and complained that she felt the basis for the contact was that her (adult) son was black. The man did not make a complaint about the contact. The officers Sergeant was directed to investigate the situation, and his findings are contained in the "Disposition" portion of this form.</p>
