23CC-0001	2023-02-16	RP reported being stopped by the officer and asking him about weapons in the vehicle. RP felt like it was at a very odd time and was strange. He believed it was due to his race.	2023-03-17	An investigation was completed. The allegation against the officer was unfounded.
