TOBACCO DIRECTORY UPDATE NOTIFICATION DECEMBER 1, 2015

Below is a summary of directory updates published on December 1, 2015.

- The manufacturer Commonwealth Brands, Inc. recertified fourteen (14) brands including Bali Shag RYO, Crowns, Davidoff, Fortuna, Gauloises, Gitanes, Malibu, McClintock RYO, Montclair, Premier RYO, Sonoma, Tuscany, USA Gold, and West. In addition, two (2) brands including Raven and Riviera were voluntarily removed and are no longer MSA compliant.
- The manufacturer Farmers Tobacco Co. of Cynthiana, Inc. recertified four (4) brands including Baron American Blend, Kentucky's Best, Kentucky's Best RYO, and VB Made in the USA.
- The manufacturer Japan Tobacco International USA, Inc. recertified one (1) brand—Export A.
- The manufacturer King Maker Marketing, Inc. recertified four (4) brands including Ace, Checkers, Gold Crest, and Hi-Val.
- The manufacturer Liggett Group LLC recertified six (6) brands including Bronson, Eve, Grand Prix, Liggett Select, Montego, and Pyramid.
- The manufacturer Nasco Products LLC recertified two (2) brands including Red Sun and SF. In addition, one (1) brand—Magic—was voluntarily removed and is no longer MSA compliant.
- The manufacturer P.T. Djarum recertified one (1) brand—Lagunas.
- The manufacturer Peter Stokkebye Tobaksfabrik AS recertified one (1) brand—Peter Stokkebye RYO.
- The manufacturer Philip Morris USA, Inc. recertified sixteen (16) brands including Alpine, Basic, Benson & Hedges, Bristol, Cambridge, Chesterfield, Commander, English Ovals, L&M, Lark, Marlboro, Merit, Parliament, Players, Saratoga, and Virginia Slims.

Please be advised that all cigarettes sold or offered for sale in Kansas must comply with the Fire Safety Standard and Firefighter Protection Act, K.S.A. 31-601 *et seq.*, and the Requirements for Sale of Cigarettes Act, K.S.A. 50-6a01 *et seq.* Accordingly, the Directory of Fire Standards Compliant Manufacturers *must* be read in conjunction with the Directory of Compliant Non-Participating Manufacturers and the Directory of Compliant Participating Manufacturers in order to determine which cigarettes are legal for sale in Kansas.
