Greetings:

K.S.A. 75-7c16(b) of the Kansas Personal and Family Protection Act, also known as the concealed carry handgun law, requires the Attorney General, on or about January 1 of each year, to submit a statistical report to the Governor, President of the Senate, the Senate Minority Leader, the Speaker of the House of Representatives and the House Minority Leader indicating the number of licenses issued, revoked, suspended and denied during the preceding fiscal year and the reasons for the revocations, suspensions and denials.

In Fiscal Year 2008, the Office of Attorney General issued 5,772 concealed carry handgun licenses. During the same period 106 applications were denied, 4 concealed carry licenses were suspended and 24 licenses were revoked.

- 1 Charged with Carrying a Concealed Handgun under the Influence of Alcohol
- 1 Charged with Aggravated Assault with a Handgun
- 1 Charged with a 2nd DUI within 5 Years

License Revocations: 24

- 10 Temporary Restraining Order (Protection from Abuse)
- 7 Temporary Restraining Order (Protection from Stalking)
- 3 Temporary/Joint Restraining Order (Divorce)
- 1 Aggravated Assault Diversion
- 1 Domestic Battery Diversion
- 1 Arrested for CUI and DUI (Refused Alcohol Test)
- 1 Pled Guilty to 2nd DUI within 5 years

During the period July 1, 2006 through November 30, 2008, the Attorney General's Office processed 16,728 applications for concealed carry handgun licenses.
