Greetings:

K.S.A. 75-7c16(b) of the Kansas Personal and Family Protection Act, also known as the concealed carry handgun law, requires the Attorney General, on or before January 1 of each year, to submit a statistical report to the Governor, President of the Senate, the Senate Minority Leader, the Speaker of the House of Representatives and the House Minority Leader indicating the number of concealed carry licenses issued, revoked, suspended and denied during the preceding fiscal year and the reasons for the revocations, suspensions and denials.

In Fiscal Year 2011, the Office of Attorney General issued 8,295 concealed carry handgun licenses. During the same period 25 applications were denied, 39 concealed carry licenses were suspended and 127 licenses were revoked.

License Denials: 25

- 16 Denied based on a disqualifying criminal history (criminal charges and convictions)
 - 3 Domestic Battery
 - 3 Controlled Substance Conviction w/Firearm
 - 1 Felony Controlled Substance Charge
 - 1 Aggravated Assault w/Firearm
 - 1 Aggravated Battery
 - 1 Criminal Threat w/Intent to Terrorize
 - 1 Burglary
 - 1 Felony Habitual Violator
 - 1 Criminal Injury to a Person w/Firearm
 - 1 Felony Theft Charge
 - 1 Domestic Related Brawling and Fighting
 - 1 Concealing Stolen Property
- 6 Denied because they moved to another state before their license was approved.
- 2 Denied because the applicant was subject to a final protection from abuse order.
- 1 Denied because they failed to pay the license fee

NOTE: Two license denials were later rescinded and subsequently approved.

<u>NOTE</u>: 12 suspended licenses were subsequently revoked following conviction for a disqualifying criminal offense.

9 suspended licenses were reinstated when charges were later dismissed or reduced to non-disqualifying misdemeanors offenses.

License Revocations: 127

- 106 Licensee moved Out-of-State
 - 5 Found to be carrying under the influence of alcohol (tested .08 or greater)
 - 2 Convicted of a Controlled Substance Offense w/Firearm
 - 2 Convicted of a Felony Controlled Substance Offense
 - 1 Convicted of Attempted Aggravated Assault on a Law Enforcement Officer w/Firearm
 - 1 Convicted of Aggravated Battery & Criminal Damage to Property
 - 1 Convicted of Indecent Liberties w/Child
 - 1 Convicted of Attempted Indecent Liberty w/Child & Aggravated Battery
 - 1 Convicted of Electronic Solicitation of a Child
 - 1 Convicted of Rape, Attempted Rape, Aggravated Sodomy & Indecent Liberties w/Child
 - 1 Convicted of Manufacturing Drugs
 - 1 Convicted of Attempted Criminal Threat
 - 1 Convicted of Misuse of Public Funds

 - 1 Involuntary Commitment for Mental Treatment

NOTE: 2 revoked licenses were later reinstated when the licensees were found to be clear of disqualifying events.

11 revoked licenses were previously suspended pending the outcome of criminal charges.
