Complaint 12/11/17	12/12/17	A car drove past an occupied, marked police car that was stationary with the engine running. The driver threw out a cellophane wrapper on the ground immediately in front of the police car. The car had heavily tinted windows and the driver's window was rolled down only enough to dislodge the trash from the top part of the window. The officer conducted a traffic stop. The act of littering and the stop were captured on video. During the stop, the driver, an African American male, admitted to throwing out the piece of cellophane. He later complained and indicated it might be racially motivated. A meeting was established to capture the driver's version of events and a good conversation was had. The driver was told we would look into the matter. It was explained that the incident was on video. He was offered a chance to watch the video on more than one occasion, but	02/17/18	Unfounded

		never chose to do so. After a couple of attempts to re-contact him we never heard back. On 2/16/18 the driver pled guilty to the charge of littering. The officer appear polite and professional during his contact and explained his actions.
