The investigation revealed she was clearly parked in a no parking zone and refused the officers request to move her car.	11/25/14	After a complete investigation no violations of regulations were discovered and no violations of the biased policing policy were observed. It appears she was issued the parking citation clearly due to a violation and subsequent refusal to move her car when asked. Race does not appear to be a factor in the officers decision making process.
