**AMENDED ORDER FOR DEFAULT JUDGMENT AGAINST DEFENDANT BRELVIS
CONSULTING, LLC D/B/A THE STUDENT LOAN HELP CENTER, LLC**

At this time this matter comes on for Plaintiff’s Motion for Default Judgment against Defendant Brelvis Consulting, LLC doing business as The Student Loan Help Center and Memorandum in Support (“Motion for Default Judgment”) comes before this Court for consideration. The State of Kansas *ex rel.* Derek Schmidt, appears by and through counsel, Assistant Attorney General Robert Reynolds. The Defendant Brelvis Consulting, LLC doing business as The Student Loan Help Center appears not and is in default.

WHEREUPON, after reviewing the Court’s file and Plaintiff’s Motion for Default Judgment, the Court finds the following:

1. Plaintiff filed its Petition on December 27, 2017.

2. Plaintiff's Petition is predicated on Defendant's violation of the Kansas Consumer Protection Act, pursuant to K.S.A 50-626(b)(2), K.S.A 50-626(b)(3), K.S.A 50-626(b)(6), K.S.A 50-627(b)(3), and K.S.A 50-627(b)(5).
3. Defendant has failed to file an Answer within 30 (thirty) days after being served with process, as required by K.S.A. 60-308(a)(3).
4. Defendant is not a minor or an incapacitated person.
5. Defendant is in default pursuant to K.S.A. 60-255.
6. The factual allegations set forth in the Plaintiff's Motion for Default are adopted by the Court as its findings of fact and conclusions of law as though fully set forth herein.

RELIEF

7. Plaintiff is entitled to all injunctive relief set forth in its Petition pursuant to K.S.A. 50-631(d) and K.S.A. 50-631(e)(1), including the following:
 8. The above-mentioned acts and practices be declared unconscionable in violation of the Kansas Consumer Protection Act, pursuant to K.S.A. 50-627;
 9. The Defendant be permanently enjoined from these and other practices in violation of the Kansas Consumer Protection Act, and from engaging in business in the State of Kansas, pursuant to K.S.A. 50-632(c)(6);
 10. The Defendant, and any employees, agents, representatives, affiliates, assignees and successors, be permanently enjoined from these and other practices in violation of the Kansas Consumer Protection Act, and from engaging in business in the state of Kansas, pursuant to K.S.A. 50-632(c)(6);
 11. The Defendant pay reasonable investigative fees and expenses to the Office of the

Kansas Attorney General, as provided by K.S.A. 50-632(c)(7);

12. The Defendants pay \$39,012.91 in restitution to be distributed to one (1) Kansas consumer, pursuant to K.S.A. 50-632(c)(2);

13. The Defendants pay civil penalties of \$10,000.00 for each violation of the Kansas Consumer Protection Act alleged herein, in the aggregate amount of \$50,000.00, as provided by K.S.A. 50-636;

14. The Defendants pay all Court costs and all costs associated with distributing and executing on any judgment made by this Court.

15. Defendant be ordered to pay all Court costs and all costs associated with distributing and executing any judgment made by this Court.

IT IS THEREFORE ORDERED, ADJUDICATED AND DECREED that Plaintiff's Motion for Default Judgment is granted.

IT IS FURTHER ORDERED, ADJUDICATED AND DECREED that Judgment is hereby entered against Defendant, Brelvis Consulting, LLC doing business as The Student Loan Help Center in favor of Plaintiff.

IT IS FURTHER ORDERED, ADJUDICATED AND DECREED that Defendant, Brelvis Consulting, LLC doing business as The Student Loan Help Center and any employees, agents, representatives, affiliates, assignees and successors are permanently enjoined from operating as a student loan debt relief assistance company in the State of Kansas.

IT IS FURTHER ORDERED, ADJUDICATED AND DECREED that Defendant, Brelvis Consulting, LLC doing business as The Student Loan Help Center pay all Court Costs and all costs associated with distributing and executing this judgment.
