MOTION AND ORDER FOR DEFAULT JUDGMENT

COMES NOW the plaintiff, State of Kansas, *ex rel.* Carla J. Stovall, Attorney General, by and through James J. Welch, Assistant Attorney General, and for her motion alleges and states as follows:

1. On or about October 22, 1998, the plaintiff brought suit against the defendant, Willard Enterprises, d/b/a Colorado Choice Meat Company, for violations of the Kansas Consumer Protection Act.
2. Defendant Willard Enterprises, d/b/a Colorado Choice Meat Company, was served via certified mail service by way of its registered agent, Mark Willard, 9671 Wendell Road, Dallas, Texas 75243.
3. Defendant has submitted to the jurisdiction of the courts of this state by transacting business within this state and has entered into consumer transactions, as defined by the


Kansas Consumer Protection Act, K.S.A. §50-624(c).

4. To date, Defendant has failed to respond to the plaintiff's petition or otherwise plead.
5. Defendant has committed a total of at least 8 violations of the Kansas Consumer Protection Act in representations to and transactions with at least one consumer.

WHEREFORE, plaintiff prays the Court to order, adjudge and decree that the Defendant is in default for failure to answer or otherwise plead in the above-captioned action by and through a licensed Kansas attorney as required by law and to grant the relief in the Petition, specifically:


- (a) the Defendant be ordered to pay \$40,000.00 civil penalties to the State of Kansas,
- (b) the Defendant be ordered to pay \$10,000.00 investigative fees, and
- (c) the Defendant be permanently enjoined from engaging in any type of consumer transaction as a supplier within the state of Kansas.
