**JOURNAL ENTRY OF DEFAULT JUDGMENT**

1. On or about January 19, 2000, the plaintiff brought suit against the defendant, Sunplus Credit, Inc., d/b/a National Bankcards, for violations of the Kansas Consumer Protection Act.
2. Defendant Sunplus Credit, Inc., d/b/a National Bankcards, was served via certified mail service on or about February 28, 2000.
3. Defendant has submitted to the jurisdiction of the courts of this state by transacting business within this state and by entering into consumer transactions, as defined by the Kansas Consumer Protection Act, K.S.A. §50-624(c).
4. To date, Defendant has failed to respond to the plaintiff's petition or otherwise plead.
5. Defendant has committed a total of at least 1,368 violations of the Kansas Consumer Protection Act in representations to and transactions involving at least 456 Kansas consumers.

WHEREFORE, Defendant is in default for failure to answer or otherwise plead in the

above-captioned action by and through a licensed Kansas attorney as required by law and relief sought in the plaintiff's Petition, specifically:

- (a) the Defendant is hereby ordered to pay restitution totaling \$15,960.00 to Kansas consumers listed in Exhibit A to the petition, each in the amount of \$35.00;
- (b) the Defendant is hereby ordered to pay \$6,840,000.00 civil penalties to the State of Kansas,
- (c) the Defendant is hereby ordered to pay \$5,000.00 investigative fees,
- (d) the Defendant is hereby permanently enjoined from engaging in consumer transactions within the state of Kansas which constitute violations of the Kansas Consumer Protection Act, as alleged in Plaintiff's petition;
- (e) Defendant is hereby ordered to pay all court costs.
