JOURNAL ENTRY OF DEFAULT JUDGMENT

1. On or about April 10, 2000, the plaintiff brought suit against the defendant, Commonwealth Bank Card Protection, Inc., for violations of the Kansas Consumer Protection Act.
2. Defendant Commonwealth Bank Card Protection, Inc., was served with the Petition and Summons via certified mail service on or about May 8, 2000.
3. Defendant has submitted to the jurisdiction of the courts of this state by transacting business within this state and by entering into consumer transactions, as defined by the Kansas Consumer Protection Act, K.S.A. §50-624(c).
4. To date, Defendant has failed to respond to the plaintiff's petition or otherwise plead.
5. Defendant has committed a total of at least 272 violations of the Kansas Consumer Protection Act in representations to and transactions involving at least 68 Kansas consumers.


WHEREFORE, Defendant is in default for failure to answer or otherwise plead in the above-captioned action by and through a licensed Kansas attorney as required by law and relief sought in the plaintiff's Petition, specifically:

- (a) the Defendant is hereby ordered to pay \$4,000.00, pursuant to K.S.A. §50-632, which, as Plaintiff acknowledges, has been paid in full as of the date of filing of this Judgment;
- (b) the Defendant is hereby permanently enjoined from engaging in deceptive and/or unconscionable consumer transactions within the state of Kansas which constitute violations of the Kansas Consumer Protection Act, as alleged in Plaintiff's petition;
