JOURNAL ENTRY OF CONSENT JUDGMENT

NOW on this 7th day of Dec 1993, the plaintiff's motion for approval of consent judgment comes before the court for consideration. The State of Kansas ex rel. Robert T. Stephan, Attorney General, appears by and through Martin J. Peck, Assistant Attorney General. Defendant Jack Phillip Cook appears on his own behalf.

WHEREUPON, the parties advise the court that they have stipulated and agreed as follows:

1. Robert T. Stephan is the Attorney General of the State of Kansas.

2. Defendant has engaged in consumer transactions within the State of Kansas.

3. Defendant admits the court has personal and subject matter jurisdiction over the parties.

4. In consideration of the State's agreement not to pursue possible violations of the Kansas Consumer Protection Act in relation to transactions between defendant and William H. Pritzel, John E. Burnett, Daniel E. Gregory, and Donald P. Ables, defendant agrees to make payments to the State of Kansas totalling \$4356.00 on the following schedule:

7. Defendant admits no wrongdoing of any kind.

8. The State of Kansas agrees to forward monies received from defendant to consumers in the following amounts:



IT IS SO ORDERED.


