## TOBACCO DIRECTORY UPDATE NOTIFICATION

**DECEMBER 15, 2022** 

Below is a summary of directory updates published on December 15, 2022.

#### Directory of Fire Standards Compliant Manufacturers

- The PM Commonwealth Brands certified the following:
  - o Crowns: 1 new brand variety
    - Green King Size Menthol Filter Hard Pack
- The PM ITG Brands LLC certified the following:
  - o Maverick: 2 new brand varieties
    - Non-Menthol 100s and King Size Filter Hard Pack
- The PM Japan Tobacco International USA had the following removed from the directory:
  - o Wings: 6 brand varieties
- The PM NASCO Products certified the following:
  - o Pinnacle: 4 brand varieties (\* NOTE: Pinnacle has not been certified on the Directory of Compliant Manufacturers, therefore, Pinnacle cigarettes are not legal to sell in Kansas)
    - 100s Menthol Filter Hard Pack
    - Full Flavor 100s and King Size Filter Hard Pack
    - Gold 100s Filter Hard Pack
- The PM RJ Reynolds certified the following:
  - o Camel: 4 new brand varieties
    - Crisp Green Non-Menthol Filter Hard Pack
    - Crush Oasis Blue Non-Menthol Filter Hard Pack
    - Crush Oasis Silver Non-Menthol Filter Hard Pack
  - Newport: 3 new brand varieties
    - EXP Lux 100s Non-Menthol Filter Hard Pack
    - EXP Max 100s Non-Menthol Filter Hard Pack
    - EXP Mix 100s Non-Menthol Filter Hard Pack

#### **Master Directory**

- NOTE: the new Master Directory provides the last four numbers of the UPC for each variety. Please note this is for reference in differentiating varieties and does not take into consideration UPCs for promotional packs which might be different. UPCs for cartons will also be different than the pack numbers.

### \*\*\* Important Notice Regarding the Sale of Cigarettes \*\*\*

Please be advised that all cigarettes sold or offered for sale in Kansas *must* comply with *both* the Fire Safety Standard and Firefighter Protection Act, K.S.A. 31-601 *et seq.*, and the Requirements for Sale of Cigarettes Act, K.S.A. 50-6a01 *et seq.* Accordingly, the Directory of Fire Standards Compliant Manufacturers *must* be read in conjunction with the Directory of Compliant Non-Participating Manufacturers and the Directory of Compliant Participating Manufacturers in order to determine which cigarettes are legal for sale in Kansas.
